AANR-SW PRESIDENT'S MESSAGE

June 2024

Greetings!

I hope all of you are preparing to attend the AANR-SW Convention at Star Ranch beginning on June 20, 2024, and continuing until Sunday, June 23rd. Convention and Facilities Chair, Dan Hawkins, has been working very closely with the folks at Star Ranch to ensure that we have a fun time with several events and lots of games, music, good food, and friendly people, all at the lovely Star Ranch facilities.

We need to take care of some very important business first of all, concerning the official meetings we will have on Friday, June 21. This year our required Notice of Meeting, with proxy form attached was sent out to our members in mid-May. Most were sent out via email, and 134 were mailed via USPS official mail (for those who do not

have a valid email address on file with AANR or who do not wish to receive the Notice via email).

We have heard from several members who have Not received these important documents either by email or USPS mail. To my knowledge, we have not received any USPS mail returned to the AANR office, unless the reason is a changed address, the person was deceased, etc. One person received the proxy form in the mail, but did not see the mailing address listed at the bottom of the Notice letter. He mailed the proxy form to me at my home address and one member sent the form to the AANR office in Kissimmee, Florida.

We want everyone to understand that the mailing address does change when the person holding the position of Corporate Secretary changes. The proxy form does not change from year to year. So, that is why we include the mailing address in the body of the Notice of Meeting letter. To make sure that all of you who regularly receive my President's Message also receive the Notice of Meeting and Proxy Form, I have copied and pasted both forms into the body of this Message – no attachments to open. Appearing immediately below is what you should have received in your email. So far, no one I know has found the Notice in their "junk" email folder, but you might look there if you wish. However, you can just use the Proxy Form below, print out the page it's on, fill it out as appropriate (you do NOT have to know the person's AANR Member number if you are listing an individual, just fill in their name and if there is a problem, such as if we have two John Smiths in our membership list, we will contact you for more information, such as where that person lives, etc.), and mail it to Wayne Kircher at the address below. This is very important, as we must provide every voting Member an opportunity to exercise their right to vote on Regional matters that will be considered at the General Assembly Meeting on June 21 st .

Dear AANR Southwest Member:

The AANR Southwest General Assembly meeting and Convention is scheduled for June 21, 2024, at Star Ranch Nudist Club, near McDade, TX. The meetings will begin at approximately 9:30 a.m. You are cordially invited to attend. If you cannot be there, we respectfully request that you complete the AANR Southwest Member Voting Proxy. You may give your proxy to another AANR Southwest member who will be attending the General Assembly meeting, or you may give it to the AANR Southwest Board of Directors, to be voted as a majority of them agree.

Officers to be elected at the General Assembly meeting include: President, Vice-President and two or more Directors. Various legislative matters, motions and Honor Awards may also be voted upon.

Complete your proxy by printing your name, AANR # (NOT the P#), and expiration date. Please sign on the line provided, and date the proxy. A separate proxy form must be completed by each member. IT IS VERY IMPORTANT TO SEND IN YOUR PROXY IF YOU CANNOT ATTEND THE MEETING. WE MUST HAVE 100 VOTES REPRESENTED IN ORDER TO CONDUCT BUSINESS.

You may give your completed proxy to another AANR Southwest member who will be attending the General Assembly meeting, or you may mail it to the address below. *If mailing your proxy, please mail it as early as possible to ensure that it arrives prior to the General Assembly meeting.*
